# FROM THE TRUSTEES

\*\*\* Beginning in June of 2025 Trustee meetings will be once a month on the 2nd Wednesday at 7p.m. \*\*\*

## **Road Work:**

The township roads suffered more damage than usual due to this winter's deeper freeze-thaw cycles. Our Road Superintendent Andy Dunlap prepared a road repair plan that the Trustees submitted to the Erie County Engineer and Erie County Commissioners. After review of the estimates by the Erie County Engineer, we may be required to receive bids on some of the work, as the estimates may be over the threshold that requires bidding by Ohio Revised Code. We will review the bids when they come in and we believe our estimates using the Oxford-Margaretta-Groton (O-M-G) road crew will be more cost effective.

The work planned is as follows:

- Huber Road paving, striping and stone on shoulder, internal estimate with township's crew \$72,015
- Lovers Lane Road paving, striping and stone on shoulder, internal estimate with township's crew \$94,170
- Higbee Road (at S curve) paving, striping and stone on shoulder, internal estimate with township's crew \$15,505

The Huber Rd work would be paid out of Township funds, and the remainder is requested from any funds that can be provided by the County Engineer and County Commissioners. In addition, as much crack sealing as can be afforded will be performed on numerous roads.

# **Bloomingville Cemetery:**

Road Superintendent Andy Dunlap proposed installing a drive at the cemetery. His proposal included adding the originally planned drive on the cemetery map and constructing a U-shaped drive for ease of access and safety. The drive was laid out and recorded on the cemetery map in 1810. Trustees approved the

plan for the drive, and the crew completed the stone

base installation. Paving will be completed next spring after allowing a year for the stone to settle. The recently purchased O-M-G mini-excavator and roller were used on the job.

# Park:

The Trustees submitted a grant application to Erie MetroParks for \$6,300, the full cost



to replace the 25+ year old swing set. If the grant is received, the swing will be purchased from and installed by PlayGround World of Avon, the provider of the other playground equipment. Trustees also received a grant from the Erie County Solid Waste Management District (ECSWMD) for 100% of the cost of replacement of the dugout benches and recycled "engineered" mulch for the playground. ECSWMD will pay for the benches and mulch made of recycled material. The Trustees and Road Superintendent have selected 100% recycled plastic benches like the picnic tables purchased with a grant last year. The current benches are warped and splintered.

Any township residents wishing to reserve the park and shelter, or teams wishing to reserve the field for league play or practice can contact Andy Dunlap at 419-357-2493. The ball field has already been reserved 3 nights a week this season.

# **Equipment:**

Trustees reviewed the status of our three trucks and determined that the 2002 International dump needed replacement. It was determined that we would downsize the fleet to two trucks to reduce capital and maintenance costs in the long term while maintaining the same snow removal capability level. Trustees decided to purchase a 2025 Ford F550 gas engine truck chassis and mount it with the toolbox and dump box from the 2020 F550. The 2025 F550 will have a salt spreader and plow unit installed. The new F550 chassis was received, Andy and his father Tim removed and installed the tool and dump boxes off the old F550, and the salt spreader was fitted. The plow unit will be installed as son as the vendor fits it into his schedule. The old 2002 dump truck will be sold by closed bid to the highest bidder (see below for details). The new truck chassis cost apporx. \$65,000 and was purchased using the Ohio Department of Administrative Services Department, Cooperative Purchasing Program. The salt amd snow equipment cost approx. \$24,000. We sold the old chassis on Gov Deals for \$36,000, so the total cost for the F550 was far less than the cost of another dump truck, which was estimated at \$215,000.

The road superintendents from Oxford, Margaretta, and Groton recommended to the respective boards for trustees that a used articulated road roller be purchased at a reasonable cost from Erie Blacktop. The O-M-G paving crew will use the roller. The price for each township would by \$5,000. Each board of trustees approved the purchase. As it articulates, this roller is more maneuverable and useful for compacting tight radius curves, driveway aprons, and around mailboxes. Both rollers can still be used on paving projects. Trustees also authorized Andy to purchase a ballfield drag to prepare the infield for better play.
